Build the talent pipeline to increase the supply of licensed mental healthcare providers who treat youth and children.

LANCASTER CLINICAL SUPERVISION COLLABORATIVE

We're assisting 30 masters-level graduates (Fellows) to earn clinical licenses. Thanks, in part, to a grant from The Steinman Foundation, we invested \$121,520 in 2020 to provide this program to 9 local agencies (for teams of Supervisors and Fellows). The program also includes monthly continuing education.

NURSING SCHOLARSHIPS

We help local nursing students begin or further their nursing careers in roles supportive of children's mental health. We invested a total of \$56,400 in 2020 in scholarships for 20 students.

CONTINUING EDUCATION & TRAINING

In 2020, we invested \$2,713 to offer practicing physical and mental healthcare providers Continuing Medical Education in topics of children's mental health.

CHILDREN'S BEHAVIORAL **HEALTH GRANTS**

In 2020, we invested \$129,395 in grants to nonprofit organizations serving Lancaster County with programs that improve access to children's mental healthcare.

MATERNAL MENTAL WELLNESS

We support mothers experiencing perinatal and postpartum mood disorders (such as postpartum depression/anxiety), and help parents increase coping skills.

MENTAL HEALTH COPAY ASSISTANCE

A Whole-Person

Approach

We help parents, and youth from birth to young adults, who are in financial need so that they can afford mental health appointments. This program reduces their copays to just \$10/visit. We invested \$37,124 in 2020 to cover the difference in their cost so they can start or maintain their therapy.




Lancaster Clinical Supervision Collaborative


